### *National Forest Foundation Grant*

Appalachian Forest Heritage Area has been awarded a Community Assistance Program Continuation grant from the National Forest Foundation to assist with capacity building over the next two years. The \$15,000 grant can be used for organizational assistance, staff support, and hands-on projects. Under this grant, AFHA will be assisting with on the ground conservation projects on the Monongahela National Forest, and will move forward with interpretive planning as well.

AFHA previously received a \$15,000 CAP grant for start-up assistance for our organization. This Continuation Grant is in recognition of our success in the first round and continuing growth needs.

The National Forest Foundation is the non-profit support group for our National Forests. The CAP grants are to promote the creation of locally-based, collaborative natural resource partnerships which seek to build ecological, social and economic sustainability. The program will support new non-profit organizations in need of start-up funds for capacity building that intend to proactively and inclusively engage the local community in forest management and conservation issues on and around National Forests.

### *Stakeholders Donate Funds*

AFHA thanks the 15 donors who have donated over \$2075 in response to our first ever fundraising appeal letter. Individual donations ran from \$10 to \$1000. The letters to our mailing list were personalized with notes from our board members and staff.

AFHA continues our policy of making newsletters, meetings, and other benefits available to all stakeholders -- everyone who expresses interest. We are asking for donations not as a membership, but as an expression of support from those who are committed to the project and able to help. Funds will be used to support the organization, and to match potential government grants.

### *Grant for Forestry Tours*

The AFHA has been awarded \$1000 from the Society of American Foresters (SAF) "Foresters Fund" to coordinate 4 educational forest tours in the northern part of the AFHA. One mission of the SAF is to advance the science, education, technology, and practice of forestry. These tours will be led by long-time partners of the AFHA and SAF members Francis Zumbrun, John Denning, Barbara Bre shock, Bob Beanblossom, and Dave McGill.

Tours will be held later this spring at the Green Ridge and Potomac-Garrett State Forests in Maryland and the Kumbrabow State Forests in West Virginia. Participants will view wildlife enhancement, recreation, and timber activities on these forests. One special feature on the Potomac-Garrett State Forest is the new "Kindness Demonstration Area" that has interpretive signs developed as part of an AFHA minigrant.

More information will be forthcoming as to the dates and times of these workshops. Tour details will be posted on the AFHA web site when available, or call AFHA at 304-636-6182.

### *National Heritage Area Designation Update*

Sen. John D. Rockefeller has agreed to sponsor a bill in the Senate designating the Appalachian Forest National Heritage Area. Sen. Ben Cardin of Maryland as agreed to co-sponsor. We expect the other Senators to also co-sponsor once we have approval of our Feasibility Study from the National Park Service.

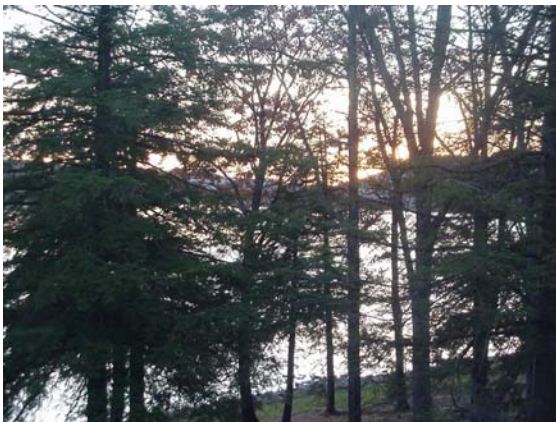
The National Park Service has approved most of our Feasibility Study, but expressed concern whether we would be able to match Federal funds. Our initial support letters were expressing support for the project, not expressing commitment of resources. New letters are requested now showing commitment or expectation of time, donated services or materials, or cash match for future Federal funds. Please send or arrange for letters if you can. 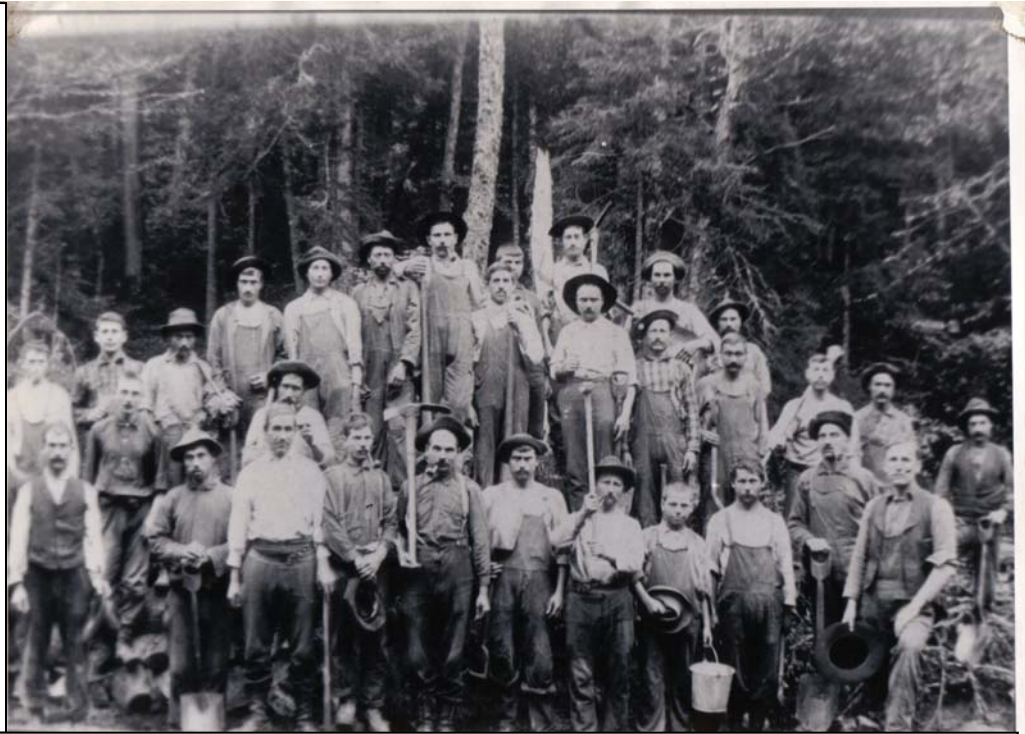
